After more than 30 years in global emerging markets, Mark has received numerous industry awards and has written several books, including "Trading with China," "The Investor's Guide to Emerging Markets," "Mobius on Emerging Markets," "Passport to Profits," "Equities—An Introduction to the Core Concepts," "Mutual Funds—An Introduction to the Core Concepts" and "Mark Mobius: An Illustrated Biography."

In 2006, Asiamoney magazine listed Mark as one of the "Top 100 Most Powerful and Influential People," stating that Mark "boasts one of the highest profiles of any investor in the region and is regarded by many in the financial industry as one of the most successful emerging markets investors over the last 20 years. Despite tough times during the financial crisis nine years ago, he still commands a strong following in the investment world and is influencing the direction of billions of investment dollars."

The World Bank and Organisation for Economic Cooperation and Development appointed Mark, Joint Chairman of the Global Corporate Governance Forum Investor Responsibility Taskforce.
