Objectives and Investment Policy

Franklin India Fund (the “**Fund**”) investment objective is to seek long-term investment growth, mainly through growth of capital.

Investment Policy

The Fund mainly invests equities of companies of any market capitalisation that are located in, or derive significant business from India.

These investments may include depositary receipts and convertible securities. To a lesser extent, the Fund may invest in private companies

SFDR category Article 8 (promotes environmental and/or social characteristics under EU regulations).

The investment manager applies a proprietary rating methodology using various ESG criteria to assess long-term opportunities and risks. The Fund favours companies with a high or improving profile and excludes or restricts investments in certain industries that are harmful to the environment or society, such as thermal coal, weapons and tobacco. The investment manager engages in dialogue with companies concerning ESG issues.

convertible securities: Bonds that offer the option or the obligation of receiving repayment of principal either in cash or shares in the company.

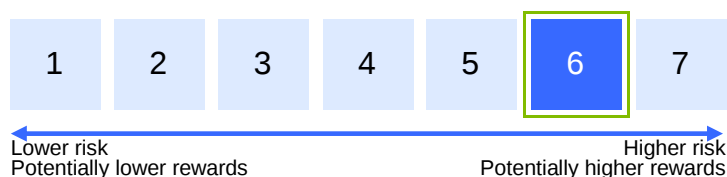
depositary receipts: Certificates of ownership that allow shares to trade in markets where they are not registered.

Why is the Fund in this specific category?

The Fund invests mainly in equity and equity-related securities of a single emerging country. Such Indian securities have historically been subject to significant price movements, frequently to a greater extent than equity markets globally. As a result, the performance of the Fund can fluctuate significantly over relatively short time periods.

Risks materially relevant not adequately captured by the indicator:

Emerging markets risk: the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, and that may be impacted by political/economic instability, lack of liquidity or transparency, or safekeeping issues.

Foreign Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. 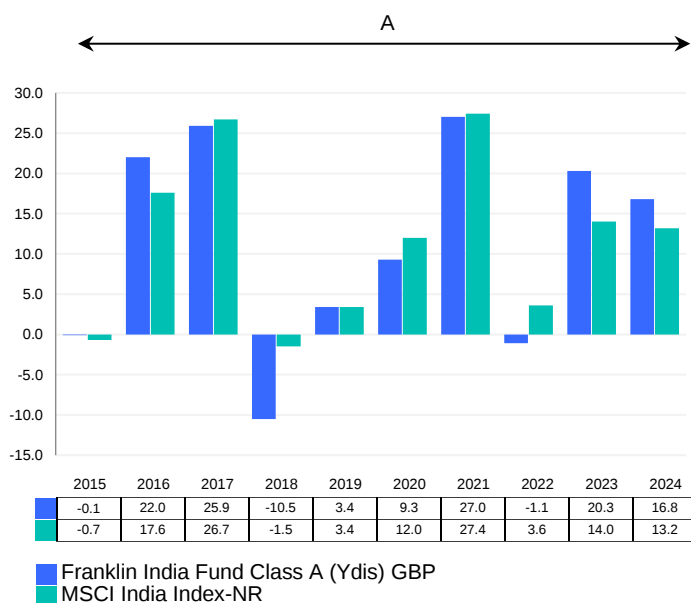
