Objectives and Investment Policy

Franklin Mutual U.S. Value Fund (the "Fund") investment objective is to seek investment growth, mainly through growth of capital, and as a secondary objective, income.

Investment Policy

The Fund mainly invests in equities of US companies of any market capitalisation.

To a lesser extent, the Fund may invest in equities and bonds issued by companies that may be restructuring or going through major corporate changes.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, but not to generate additional income or growth.

Strategy The investment manager uses Fundamental research and analysis to select companies that appear to be undervalued.

SFDR category Article 6 (does not promote environmental and/or social characteristics or have a sustainable investment objective under EU regulations).

Base currency US dollar (USD).

Benchmark(s) Linked Russell 1000 Value Index-NR. Used mainly for performance comparison.



Why is the Fund in this specific category?

The Fund invests mainly in equity and equity-related securities of companies located in the U.S. Such securities have historically been subject to significant price movements that may occur suddenly due to market or company-specific factors. As a result, the performance of the Fund can fluctuate significantly over relatively short time periods.


