Objectives and Investment Policy

FTGF ClearBridge Global Infrastructure Income Fund (the "Fund") investment objective is to seek long-term investment growth, through a combination of income and growth of capital (total return).

The Fund mainly invests in equities of companies in infrastructure sectors in developed markets, such as utilities, transport, community and social infrastructure, and communications.

To a lesser extent, the fund may invest in equity and equity-related securities in emerging markets. The fund may also have limited exposure to infrastructure-related real estate funds.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

Strategy In a bottom-up process, the investment manager uses
Fundamental analysis to select a concentrated portfolio of companies that
appear to have a long life span, offer predictable cash flows, have low
earnings volatility and benefit from limited competition due to high barriers
to entry. It also favours companies that tend to be better protected from

What does this indicator mean and what are its limits?


