### Objectives and Investment Policy

Franklin Mutual European Fund (the “Fund”) investment objective is to seek long-term investment growth, mainly through growth of capital and, as a secondary objective, income.

#### Investment Policy

The Fund mainly invests in equities of companies of any market capitalisation that are located in or derive most of their business from Europe, but with a substantial part of issuers in Western Europe. These investments may include convertible securities.

To a lesser extent, the Fund may invest in equities and bonds issued by companies that may be restructuring or going through major corporate changes.

**Derivatives and techniques** The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

**Strategy** The investment manager uses Fundamental analysis to select companies that appear to be undervalued.

**SFDR category** Article 8 (promotes environmental and/or social characteristics under EU regulations).

In promoting the fund’s environmental and social characteristics, the investment manager commits to maintaining a greenhouse gas intensity (scope 1 and 2) at least 20% below that of the benchmark and supporting board gender diversity. Through their proprietary analysis, the investment manager may also consider other environmental, social and governance (ESG) criteria to assess long-term opportunities and risks. The fund also excludes or restricts investments in certain industries that are harmful to the environment or society, such as thermal coal, weapons and tobacco. The investment manager may engage in dialogue with companies concerning ESG issues.


**derivatives:** Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

#### Why is the Fund in this specific category?

The Fund invests mainly in equity and equity-related securities of companies located in or doing significant business in European countries. Such securities have historically been subject to significant price movements that may occur suddenly due to market or company-specific factors. As a result, the performance of the Fund can fluctuate considerably over time.

#### Risks materially relevant not adequately captured by the indicator:

**Derivative Instruments risk:** the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.


