Objectives and Investment Policy

Franklin Income Fund (the “Fund”) investment objective is to seek to maximise income and growth of capital (total return).

Investment Policy

The Fund mainly invests in equities and corporate and government bonds of US issuers. Some of the bond investments may be below investment grade.

These investments may include convertible securities and to a lesser extent the Fund may invest in depositary receipts.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

Strategy The investment manager combines macroeconomic, interest rate, credit and issuer analysis to flexibly allocate investments across asset classes based on market conditions. For each asset class, the investment manager then selects securities that appear to offer both attractive income and total return potential.

- are interested in exposure to a mixed asset allocation, mainly in the US as part of a diversified portfolio
- have a medium to high risk profile and can tolerate significant short-term changes in the share price

Terms to Understand

bonds, below investment grade: Bonds represent an obligation to repay a debt, along with interest. Below investment grade bonds generally pay higher interest rates but are considered less likely to make all scheduled payments or repay the initial debt.

convertible securities: Bonds that offer the option or the obligation of receiving repayment of principal either in cash or shares in the company.

derivatives: Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

equities: Securities that represent partial ownership of a company.

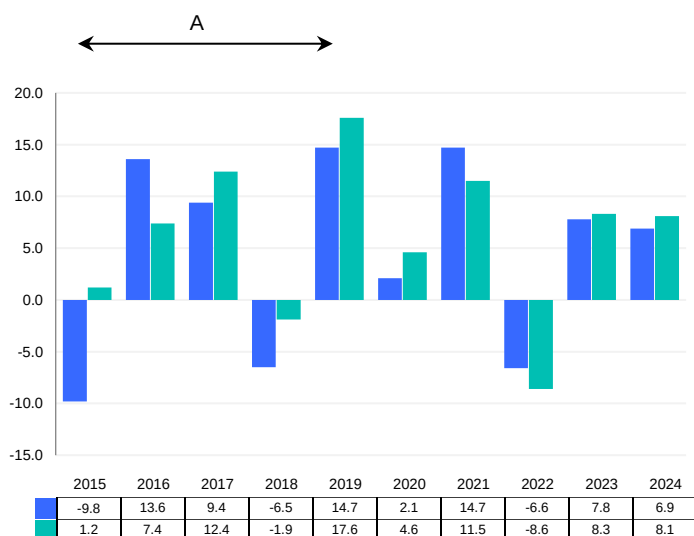
