Objectives and Investment Policy

Franklin Mutual Global Discovery Fund (the "Fund") investment objective is to seek investment growth, through growth of capital.

Investment Policy

The Fund mainly invests in equities of companies of large and medium market capitalisation (with at least \$US1.5 billion in market capitalisation) anywhere in the world.

To a lesser extent, the Fund may invest in government bonds as well as in equities and bonds issued by companies that may be restructuring or going through major corporate changes.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

Strategy The investment manager uses Fundamental research and analysis to select companies that appear to be undervalued.

SFDR category Article 8 (promotes environmental and/or social characteristics under EU regulations).

In promoting the fund's environmental and social characteristics, the In promoting the fund's environmental and social characteristics, the investment manager commits to maintaining a greenhouse gas intensity (scope 1 and 2) at least 20% below that of the benchmark and supporting board gender diversity. Through their proprietary analysis, the investment manager may also consider other environmental, social and governance (ESG) criteria to assess long-term opportunities and risks. The fund also excludes or restricts investments in certain industries that are harmful to the environment or society, such as thermal coal, weapons and tobacco. The investment manager may engage in dialogue with companies concerning ESG issues concerning ESG issues.


