Objectives and Investment Policy

Templeton European Insights Fund (the “Fund”) investment objective is to seek long-term investment growth, through growth of capital.

Investment Policy

The Fund mainly invests in equities of companies of any market capitalisation that are located in, or derive significant business from, European countries.

These investments may include convertible securities and structured products.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth (in accordance with the risk profile of the Fund).

SFDR category Article 8 (promotes environmental and/or social characteristics under EU regulations). The investment manager applies a proprietary methodology using various ESG criteria to assess long-term opportunities and risks. The Fund favours issuers with a high or improving profile and excludes or restricts investments in certain industries that are harmful to the environment or society, such as weapons, tobacco. The investment manager engages in dialogue with companies concerning ESG issues.

convertible securities: Bonds that offer the option or the obligation of receiving repayment of principal either in cash or shares in the company.

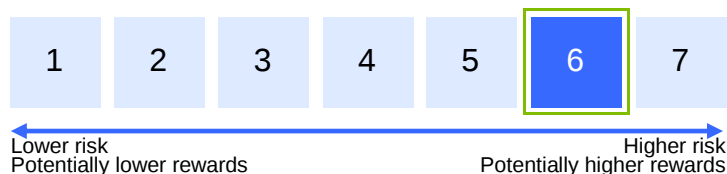
derivatives: Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

Why is the Fund in this specific category?

The Fund invests mainly in equity securities of companies located in or doing significant business in European countries. Such securities have historically been subject to significant price movements that may occur suddenly due to market or company-specific factors. As a result, the performance of the Fund can fluctuate significantly over relatively short time periods.

Risks materially relevant not adequately captured by the indicator:

Derivative Instruments risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

Foreign Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Such risk may be triggered by (but not limited to) unexpected events such as environmental disasters or pandemics. Reduced liquidity may have a negative impact on the price of the assets.

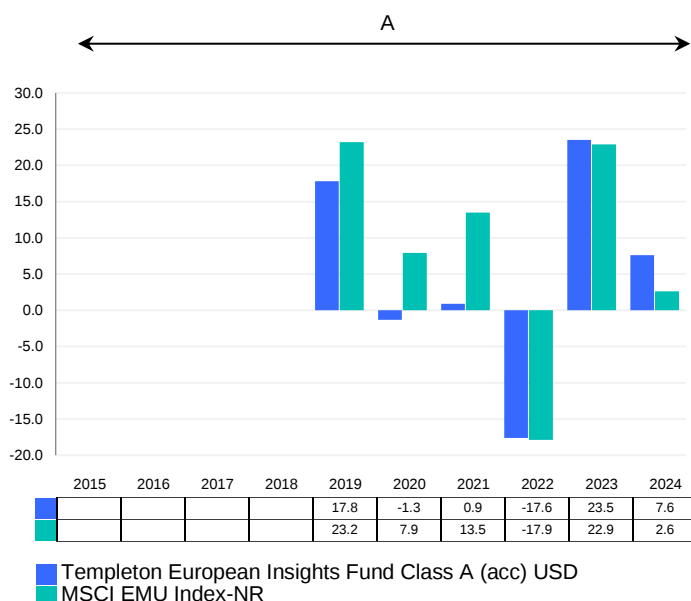
