#### **Objectives and Investment Policy**

ClearBridge UK Equity Income Fund (the "Fund") investment objective is to seek to generate an income in excess of the benchmark (net of fees), together with investment growth over a 3 to 5-year period.

#### **Investment Policy**

The Fund mainly invests in equities of companies of large capitalisation that are located in, or having their principal business activities in, the United Kingdom.

To a lesser extent, the Fund may invest in corporate and government bonds anywhere in the world.

**Derivatives and techniques** The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth (in accordance with the risk profile of the Fund).

**SFDR category** Article 6 (does not promote environmental and/or social characteristics or have a sustainable investment objective under EU regulations).

Base currency UK Sterling (GBP)

**Benchmark(s)** FTSE ALL-Share Index. Used for outperformance objective and performance comparison.

The Fund is actively managed. Though many of the Fund's equity securities are likely to be represented in the benchmark, the Investment Manager has broad discretion to deviate, even significantly, from its composition and weightings.



## Why is the Fund in this specific category?

The Fund invests mainly in equity securities listed on the London Stock Exchange, but may to a lesser extent also invest in debt securities or convertible securities of UK issuers. Such securities have historically been subject to price movements due to company-specific factors and movements in the equity and fixed income markets of the UK generally. As a result, the performance of the Fund can fluctuate significantly over relatively short time periods.

## Risks materially relevant not adequately captured by the indicator:


